REGULAR MEETING OF THE BOARD OF DIRECTORS Wednesday, February 16, 2022

The Governing Board of the Southern Inyo Fire Protection District held a regular (teleconference) business meeting on Wednesday, February 16, 2022 at 6pm via Zoom.

I. Call to order and determination of quorum

A. Present: Robin Flinchum, Christy Horne, Jon Zellhoefer, Gary Barkley on phone. Mike Jerry, Danny Macbrohn, Angie Sinohui, Larry Levy. Flinchum calls meeting to order at 6:00 and established quorum.

Ia. Discuss re-resolution to follow Zoom meeting rules pursuant to AB 361

A. Flinchum: Is AB 361 still in place? Horne moves to adopt re-resolution. Zellhoefer seconds. Carries 4-0-0.

 - c. Issue with there being two firefighters capable of running it. Only the FireCat is fully equipped right now. Rob Zmuda has submitted an application. Danny and Flinchum will consider his application. Zellhoefer moves to send FireCat out to CV at the end of next week. Barkley seconds. Carries 4-0-0.

 - a. Zellhoefer talked to other counties. They don't require permits for tanks 5000 or smaller. So everyone puts in two 5ks. Barkley: Could get the engineering on the 10k tank for \$600 and another \$600 for the stamp.
 - b. Flinchum: We need to test the tank. Larry: We should be able to see what we need to from the inspection hatch. Will be inspected for next meeting.
