REGULAR MEETING OF THE BOARD OF DIRECTORS Wednesday, May 18, 2022

The Governing Board of the Southern Inyo Fire Protection District held a regular (teleconference) business meeting on Wednesday, May 18, 2022 at 6pm via Zoom.

Call to order and determination of quorum
