 - a. Until we know for a fact that this is an annual thing, we won't increase stipends for first responders.
 - b. Zellhoefer recommends using this for the SCBA tanks.
 - c. Flinchum will call Kingsley. Chief will find out more info from chief's meeting and then we will make decision on how to spend it.


